Who are we?

COSL is a s.501(c)(3) nonprofit corporation formed by a collective of creators and activists convinced of the potential for technology to be a positive force for human creativity and connection. We believe that online safety can coexist with full respect for online rights and freedoms, and indeed that these values both depend on each other.

Mission & Vision: To empower individuals and communities to thrive online by building safer spaces, fostering creativity, combating harm, and championing digital rights and freedom. We aim



to become the leading incubator hub for independent projects created by online community members that align with this mission.

Jeremy is a human rights lawyer and trust and safety consultant, with 20 years of nonprofit experience.

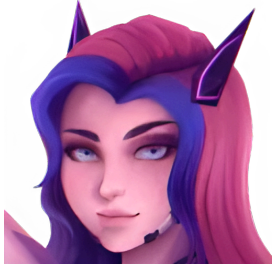

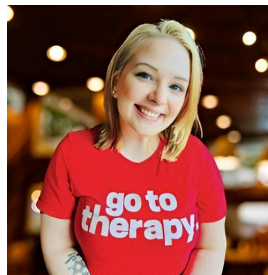

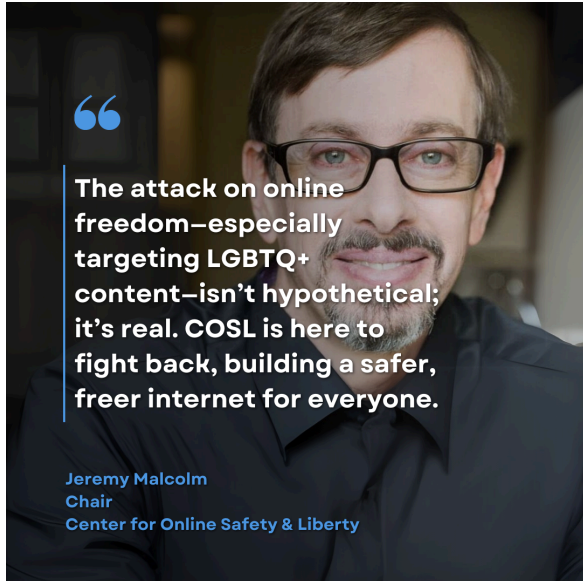

How long do we take to respond to project submissions?

Unlike typical grant proposals, the process of proposing a project for fiscal sponsorship by COSL is informal and lightweight. Your proposal will be considered by our Board of Directors, and you may be invited to provide either a live Q&A or to provide a recorded statement for its consideration. A final response should be provided within 30 days, at which time you will be provided with a sponsorship agreement outlining your responsibilities as a fiscally sponsored project.

Note that fiscal sponsorship does not imply financial sponsorship, and COSL needs to achieve a balance between projects that generate revenue for COSL and those that expend its funds. Therefore we encourage you to plan for your project to be financially self-sufficient—you can of course fundraise to support it through COSL.
